ELIGIBLE BREEDS

Only purebred Afghan Hounds, Azawakhs*, Basenjis, Borzoi, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Norrbottenspets*, Peruvian Inca Orchid*, Pharaoh Hounds, Portuguese Podengos*, Portuguese Podengo Pequots, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis*, Thai Ridgebacks* and Whippets that are one year of age or older and have been registered with the American Kennel Club, the AKC Foundation Stock Service, an AKC recognized foreign registry or that have been granted an Purebred Alternative Listing (PAL/ILP) may be entered. FSS breeds are denoted with an asterisk.

LURE COURSING TEST

JC TEST RUNS: Open to all hounds of an eligible breed. A hound, at least 12 months of age, running alone shall receive a certifications from a Judge on one date and a second certification from a different Judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

QC TEST RUNS: Open to all hounds of an eligible breed. A hound at least 12 months of age (Qualifying Hound) running with another hound of the same breed or another breed with a similar running style (Partner Hound) shall receive certification from a licensed judge, stating that the hound completed a 600-yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. **The handler presenting the Qualifying Hound shall be responsible for providing the Partner Hound for the test. It is recommended that every Qualifying Hound practice with other hounds prior to being presented for a QC test.**

LURE COURSING TRIAL

OPEN STAKE: Open to hounds that have obtained an AKC Qualified Courser Certificate, an ASFA Field Champion title, or a CKC Field Champion title. Hounds that have earned an AKC Field Champion title are not eligible to enter the Open Stake.

SPECIAL STAKE: Open to hounds that have earned their AKC Field Champion title.

OPEN VETERAN STAKE: Open to hounds that are eligible to enter the Open or Special Stakes and have reached 6 years of age on the day of the trial, except Irish Wolfhounds at 5 years of age, and Afghan Hounds, Rhodesian Ridgebacks and Whippets at 7 years of age.

SINGLE STAKE: Open to hounds including those disqualified to run in other stakes.

Portuguese Podengo Pequenos, and FSS breeds are ineligible to compete for BIF.

ENTRY INFORMATION

1. Hounds not present at the time of roll call will be scratched after a 5 minute grace period.
2. Each entry will be examined at inspection for breed disqualifications.
3. Bitches in season, hounds with breed disqualifications (except for the Single Stake) and lame hounds will be excused and have their entry fees refunded.
4. Spayed and neutered hounds, without breed disqualifications, may be entered.
5. Monorchid and cryptorchid hounds are ineligible to participate.

OPERATIONAL INFORMATION

1. All hounds will run twice, in trios, if possible, or braces unless excused, dismissed or disqualified.
2. Each course will be reversed for the final runs and again for Best of Breed but the Best in Field running direction shall be determined by the judge(s).
3. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION

1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. SASC assumes no liability for injury to any person or dog before, during or after the Tests and Trials.

SO CAL CUP QUALIFYING EVENTS

For any hound that enters these trials, they will accumulate SoCal points based on the number of dogs defeated within a particular sighthound breed. The dogs defeated are calculated on cumulative score without regard to the stake entered (i.e. open, special, veteran). Of the 14 scheduled trials, your hound must have minimally competed in 8 of them to attain eligibility into the SoCal Cup final in December.

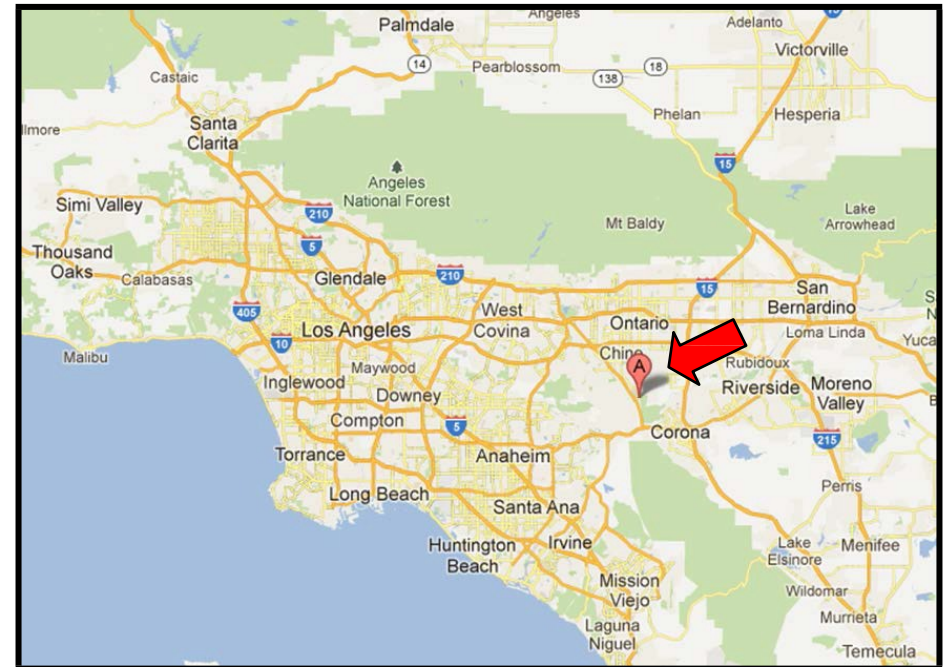

DIRECTIONS

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From the Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From San Gabriel Valley: Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.

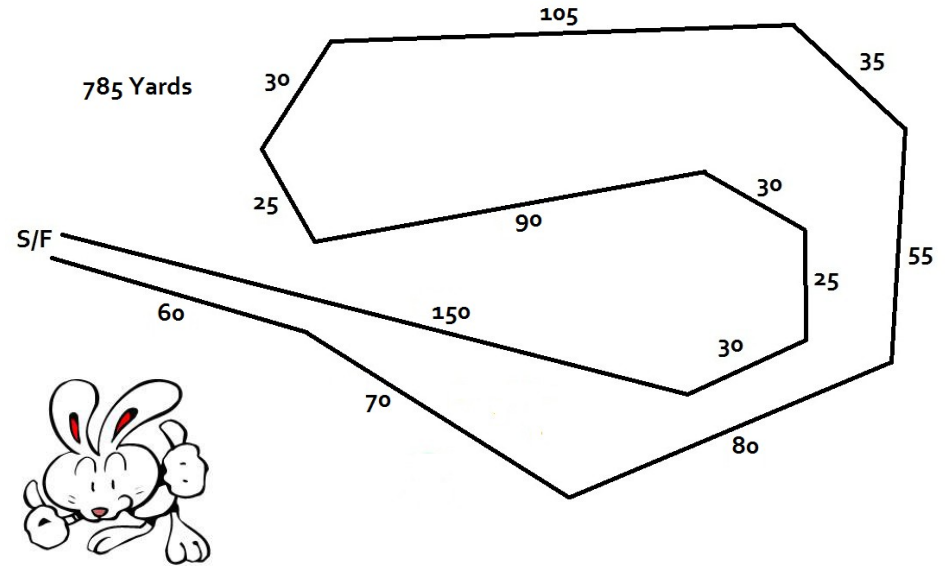

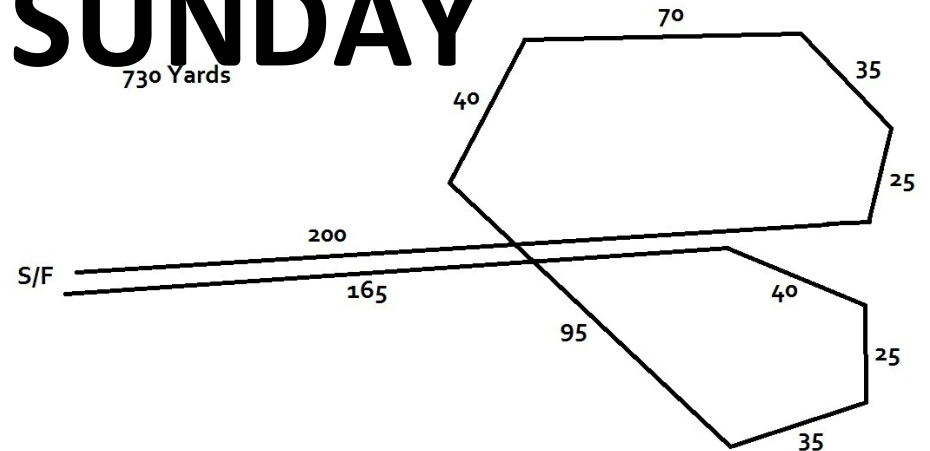

Davalya & Sacre' Memorial Lure Coursing Saluki Continuum

This trophy is offered by Arnett & Jane Taylor, Khamsa Salukis, and Sharon Walls & Mark Heddleston, Obi-Wan Salukis, in memory of Terry Herbert, Davalya, and Tom Stoner, Sacre', for their contribution to salukis and their membership to San Angeles Saluki Club over the years.

The trophy is to be offered at the two day all sighthound lure coursing event in Southern California presented by San Angeles Saluki Club as a continuum for salukis. The continuum will be tallied as follows and the high score saluki at the end of the second day will be deemed the Davalya & Sacre' Memorial Lure Coursing Continuum Winner:

All salukis entered in all stakes shall have their individual scores from preliminary and final runs tallied from both days. The addition of a placement point value for their individual placement in the stake entered will be added as well. The resultant high score at the end of the second day will be the winner of the continuum trophy.

The stake placement point values are as follows --

- 1st = 4 points
- 2nd = 3 points
- 3rd = 2 points
- 4th = 1 points

A sample of calculations are as follows (this is a sample of how the point will be calculated and does not include all placements for each stake). If there is a tie in the final score with placement points, a run off with all salukis tied for scores will be held and single stake entry ties will be run individually. If no time allows for run offs, all hounds tied will share the Continuum award title.

The trophy is a large serving tray with photo frame cut outs in the base covered with glass. Inside the cut outs are images in memory of Terry Herbert and Tom Stoner. Name plates will be engraved and mounted along the sides with the winner's name and year. The continuum trophy will be awarded each year that the back to back all sighthound lure trials are offered by San Angeles Saluki Club. If the owner/co-owner of the winning saluki is a member of San Angeles Saluki Club, the member may take the trophy home until the next award date. If the owner/co-owner of the winning saluki is not a member of the San Angeles Saluki Club, the trophy will remain in the possession of the offering people and a memento of the win will be awarded.
